## 33. Adoption of Previous Council Meeting Minutes:

2022/0897/FUL Temporary installation of mobile home with associated ground works as chef's accommodation for up to one year

2022/1097/APP Approval of details reserved by conditions 3 - (sample panel - walling), 4 - (sample panel - roofing) on planning consent 2021/2811/HSE (Erection of swimming pool & associated pool house)

There was considerable discussion about this application but in the end it was agreed by the meeting to refuse the application with the following comments:

The Council consider the locating of a mobile home so close to a grade 2 listed building as inappropriate in it's proximity and visibility.

The Council considers this to be an unnecessary development as there is already accommodation in the main building that could be utilised as living space for the chef. The Council is aware of the potential adverse impact on the local community if this was allowed, even if up to a year, as it would set a precedent for this type of development in an area where there is already a history of mobile homes being installed, or attempted to be installed, with or without permission on small plots of land. As soon as the application was submitted a mobile home was installed on the site, pre-empting a decision by MDC. It has however, been impossible to locate it as per the plans submitted and so it has been installed in a different place in the pub car park. There is local concern that if permission were granted for the temporary locating of the mobile home it would not be removed within the year and would be allowed to remain due to lack of enforcement.
